General Rules and Regulations

- Definition of Terms: Henceforth, under the definition of terms, the word "Event" refers to AGRITECHNICA ASIA & HORTI ASIA Regional Summit 2021. The "Organizer" refers to VNU Exhibitions Asia Pacific Co., Ltd. and DLG International GmbH. The "Sponsor/Exhibitor" refers to all corporations, individuals, associations, or organizations and the "Delegate" refers to all attendees that have submitted a registration contract and have paid the down payment.
- Fees are inclusive of event materials and exhibition admission tickets.
- Payment Terms: Following completion and return of the registration form, full payment is required within 30 days from receipt of invoice. Payment must be received prior to the event date. Due to limited event space, we advise early registration to avoid disappointment. A 50% cancellation fee will be charged under the term outlines below. We reserve the right to refuse admission if payment is not received on time.
- Installation and Removal: The Sponsor/Exhibitor is responsible for removing their installations and materials, and restoring the stand package to its original condition within the period stipulated by the Organizer. The Sponsor/Exhibitor should indemnify the Organizer on any losses caused by delay or damage to the exhibition area.
- Cancellation/Substitution: Provided the total fee has been paid, substitutions of the Delegate at no extra charge up to 14 days before the event are allowed. Substitutions between 14 days and the date of the event will be allowed subject to an administration fee of equal to 10% of the total fee that is to be transferred. All other bookings carry the 50% cancellation liability immediately after a signed registration contract has been received by the Organizer (as defined above). Payment terms are 30 days and payment must be made prior to the start of the event. Non-payment or non-attendance does not constitute cancellation. By signing this contract, the Sponsor/Exhibitor/Delegate agrees that in case of dispute or cancellation of this contract that the Organizer will not be able to mitigate its losses for any less than 50% of the total contract value. If, for any reason, the Organizer decides to cancel or postpone the event, the Organizer is not responsible for covering airfare, extra hotel room, or other travel costs incurred by the Sponsor/Exhibitor/Delegate. Event content is subject to change without notice.
- Copyrights: All intellectual property rights in all materials produced or distributed by the Organizer in connection with this event is expressly reserved and any unauthorized duplication, publication or distribution is prohibited.
- Important note: While every reasonable effort will be made to adhere to the sponsorship package, the Organizer reserves the right to change event dates, sites or location or omit event features, or merge the event with another event, as it deems necessary without penalty and in such situations no refunds or alternative offers shall be made. In the event that the Organizer permanently cancels the event for any reason whatsoever (excluding any force majeure occurrence) and provided that the event is not postponed to a later date nor is merged with another event, the total registration fee will be refunded.
